## Thank you for choosing us to be your private label experts. We are excited to help you develop your brand. We hope you will find this to be a rewarding endeavor!

## A few design pointers before we begin:

- · Our designer will assist you and provide advice throughout the design process to determine the best look for your labels
- · Our designer will adapt and format your branding \*Design Fee may apply
- · Please provide all available brand assets, so our designer can duplicate your branding. (your logo, any product photos, design templates, any vector files, any PDF/AI files, fonts to use/font files if applicable, and pantone colors for your brand)
- · IMAGES FOUND VIA WEB SEARCH ARE NOT PERMITTED (TO PREVENT COPYRIGHT ISSUES)

## FDA Regulatory Compliance (Sunscreen Products)

- · Per FDA requirements of SPF products, labels MUST display the following:
  - The Drug Facts panel The wording of the Drug Facts CANNOT be modified, and it must be displayed in a legible font
  - · Broad Spectrum & SPF Value (in the same size and font) on the front
  - · Water resistance information (if applicable) on the front
  - · Product weight on the front panel
  - · "Manufactured for" information
- $\cdot$  Our designer will assist in FDA compliance to ensure complete adherence to FDA regulations
  - · "Must include the statement of identity (Sunscreen) on the front of the package"

#### Fees

- THERE IS A ONE-TIME INITIAL FORMAT FEE PER SKU. This includes initial label design time with up to 3 label revisions
- Fees are as follows:
  - \$100 for your first sku
  - · \$25 per additional sku
  - The format fee for each sku can be waived if your initial order is 48+ units of that sku
- · Our hourly design rate is \$55/hour. This will be applicable when revisions exceed the included three
- · As our designer begins work on your labels, a deposit of \$250 is required (applied to your initial order.) This does not apply if
- you design your own labels
- · If you wish to re-design your label our hourly design rate of \$55/hour will be applied to your order.

### Order Minimums

- · Your first private label order MUST include 24+ units per sku
- · All other orders have a minimum of 12 units per sku

#### Replacements

- · Your satisfaction is important to us. If you receive damaged products, you may return them for replacement
- · Returns for replacement must be completed within thirty days of order date
- · Please make these claims within 10 days from receipt of products
- · Private label products are NOT eligible for refund, as they are custom produced for your practice

### **Final Note**

- · Any private label products sold may not be referred to, or compared with any Fallene Ltd brands, including TIZO® or generic TIZO<sup>®</sup> products
- · The products are your brand, and will be referred to as your brand
- · Production time is approximately 10-14 business days
- · Your sales rep is happy to assist you with product and formula education as needed
